# Instructions

Your notary process begins only after we receive all required documents that we emailed to you. **New notaries** must include their **notary education certificate**. Please review your application carefully. If a correction needs to be made, please line through it and neatly correct it in blue ink. There can be no "white out" anywhere on the application or bond.

#### **Important Guidelines:**

- Name Requirement: Your full name must be on the application. On the Oath of Office, you can use an initial for your middle name (e.g., John R. Doe is acceptable, but J.R. Doe is not).
- Signature: Your signature must match exactly across all documents—Oath and bond.
- Affidavit of Character: A non-family member who knows you must sign this section. Co-workers are commonly used.
- Bond Signature: You must sign the State of Florida Bond of Notary Public on the "Signature of Applicant" line.

#### **Submission Instructions:**

- Original, single-sided forms are required—no double-sided printing.
- If employed, include your business name and address if not pre-filled.
- Mail all required documents with original wet ink signatures:
  - 1. **Page 1** Notary Public Commission Application (*Affidavit of Character must be signed by a non-family member*).
  - 2. Page 2 Oath of Office (Sign and print your name).
  - 3. Page 3 State of Florida Bond of Notary Public (Sign the bond).
  - 4. New Notaries must include their **3-Hour Education Certificate**.

## Please do not email your forms to us or digitally sign as the state requires the original application, oath and bond with wet ink signatures.

New Notaries: Please do not send your application without the notary education certificate.

Once we receive your signed application, oath, bond and education certificate in the mail, you can expect to receive your notary commission, self-inking stamp and any other supplies within four weeks based on current state processing time.

**Remote Online Notaries (RON):** If you are a new or renewing notary who has purchased our RON package, please do not mail those instructions, RON application, or RON education certificate to us. They must go to the Tallahassee address listed on the RON instructions **after** your traditional notary is approved.

Section 817.234(1)(b), F.S. "Any person who knowingly and with intent to injure, defraud, or deceive any insurer files a statement of claim or an application containing any false, incomplete, or misleading information is guilty of a felony in the third degree."
